Since a field trip is an official school activity, all school rules and procedures apply. For any overnight trip, there are additional rules and regulations to be obeyed. You are asked to read these rules and regulations and sign where designated. Any infractions may result in the removal of a student from a program with loss of credit. Further appropriate disciplinary action including suspension or expulsion may also result.

The regulations are as follows:

- A. The possession or transfer of alcoholic beverages and /or drugs, including look-alikes and drug paraphernalia is forbidden under any circumstances. Students may not have alcohol or drugs in their rooms and may not be present where alcohol is being consumed.
- B. Students are expected to attend all activities, workshops and meetings.
- C. Students may not use or possess smoking materials or tobacco.
- D. Appropriate attire is expected at conferences.
- E. Identification badges are to be worn at all times when appropriate.
- F. Members of the opposite sex are not allowed in the hotel room of another person at any time.
- G. All students must be in their room by the designated curfew and remain in their rooms.
- H. No student is allowed to leave the hotel at night unless accompanied by a chaperone.
- I. No student will be allowed to remain at the hotel in the evening unless one of the chaperones remains to supervise.
